
If you are having any difficulty finding us, or will be late please call Ronnie 778.867.7152

WHAT TO EXPECT AND HOW TO PREPARE

Your call and wrap time

Please review the call sheet on page 3, this will tell you what time you will need to be at the studio (highlighted in yellow), what time you are scheduled to film at and your wrap time. Please note we have everyone scheduled for 1.5 hours, but we hope to have you in and out in less time.

Arriving at the studio

When you arrive at the studio please be aware of the sign on the door, when we are filming the sign will say "filming in progress - please do not enter", if this is the case please wait until one of the Production Assistants opens the door. Our production assistant will be looking for arrivals your wait shouldn't be more than 5-7 minutes.

The release form

When you arrive you will first be asked to sign a release form. This form is included in the package on page 8. We will provide you with a copy to sign the day of your filming. The one included here is just for your reference so you can review it before the shoot. If you have any questions or concerns with the release form please let me know before hand.

Hair and make-up

We have a hair and make-up artist on set. We ask you please come in with your hair and make-up done how you normally would do it and our make-up artist will do touch ups for you, and get you camera ready.

The interview

Once all this is done, you will sit down to do your on-camera interview. The direction and what we will be talking about, will be a follow up from your in-person or telephone interview that you had with Brandy and/or Jamie. We will provide you with a talking points for your interview by Thursday, so you can review and feel as prepared as possible.

Your comfort

We will do our best to ensure you are comfortable. Food, tea, coffee and juice will be available all day. In addition, the studio has wifi should you wish to bring your laptop or tablet to keep you occupied while you are waiting. We also suggest you bring a warm layer for when you are waiting, the studio can be cold at times.
